Line extensions – First 1,000 feet requires a prepayment of 100% of estimated cost of construction as calculated under the standard plant schedule. (This first 1000' charge is refundable in full at the time of completion of construction and installation of permanent service. Any footage over 1,000 is paid for by the consumer.)

The cost per line varies depending on structures used during construction. Contact our office to receive an estimate.

Relocation of a Line - The consumer pays 40% of the cost for moving the line. Credit is given for depreciated value of retired materials.
